Overview

This document discloses licenses for open-source software modules that reside in the operating environment of StorNext[®] XWD and XWE appliances.

Similar documents exist for the StorNext software itself, for Lattus®, for Quantum Advanced Reporting®, and other Quantum products. These documents can be found online at

The full open-source profile of StorNext appliances is described by this document, plus the open-source license documents for the StorNext software and for Advanced Reporting, all taken together.

Upon request and pursuant to the applicable licenses, Quantum will furnish a DVD containing source code for the open-source modules.

Stornext Appliances are delivered with CentOS 7. Individual packages that comprise the CentOS distribution come with their own licenses. The texts of these licenses are located in the package's source code and permit you to run, copy, modify, and redistribute the software package (subject to certain obligations in some cases) both in source code and binary code forms.

• Note: The open source licenses and details in this topic will be updated as their applicable packages are updated in future releases.

<u>Preamble</u>

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public License is intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users. 


When we speak of free software, we are referring to freedom, not price. To protect your rights, we need to prevent others from denying you these rights or asking you to surrender the rights. Therefore, you have certain responsibilities if you distribute copies of the software, or if you modify it: responsibilities to respect the freedom of others.

7. Conveying Non–Source Forms.

A. HISTORY OF THE SOFTWARE


Python was created in the early 1990s by Guido van Rossum at Stichting Mathematisch Centrum (CWI, see http://www.cwi.nl) in the Netherlands as a successor of a language called ABC. Guido remains Python's principal author, although it includes many contributions from others.

In 1995, Guido continued his work on Python at the Corporation for National Research Initiatives (CNRI, see http://www.cnri.reston.va.us) in Reston, Virginia where he released several versions of the software.

In May 2000, Guido and the Python core development team moved to BeOpen.com to form the BeOpen PythonLabs team. In October of the same year, the PythonLabs team moved to Digital Creations (now Zope Corporation, see http://www.zope.com). In 2001, the Python Software Foundation (PSF, see http://www.python.org/psf/) was formed, a non-profit organization created specifically to own Python-related Intellectual Property. Zope Corporation is a sponsoring member of the PSF.

All Python releases are Open Source (see http://www.opensource.org for the Open Source Definition). Historically, most, but not all, Python releases have also been GPL-compatible; the table below summarizes the various releases.

- (1) GPL-compatible doesn't mean that we're distributing Python under the GPL. All Python licenses, unlike the GPL, let you distribute a modified version without making your changes open source. The GPL-compatible licenses make it possible to combine Python with other software that is released under the GPL; the others don't.
- (2) According to Richard Stallman, 1.6.1 is not GPL-compatible, because its license has a choice of law clause. According to CNRI, however, Stallman's lawyer has told CNRI's lawyer that 1.6.1 is "not incompatible" with the GPL.


