Overview

DXi 4.8.0 Software (with Advanced Reporting) is delivered with CentOS 7. Individual packages that comprise the CentOS distribution come with their own licenses. The texts of these licenses are located in the package's source code and permit you to run, copy, modify, and redistribute the software package (subject to certain obligations in some cases) both in source code and binary code forms.

 Note: The open source licenses and details in this topic will be updated as their applicable packages are updated in future releases.

The following table lists open-source software components used in DXi 4.8.0 Software that have been added to the base operating system, patched, or otherwise included with the product. For each component, the associated licenses are provided. Upon request, Quantum will furnish a DVD containing source code for all of these open-source modules, both the base CentOS modules and the additional packages listed here.

• **Note:** The licenses in this topic work with DXi 4.0 and subsequent releases (for example, 4.0.1, 4.0.1.1, 4.0.3, 4.1, etc.), except where noted.

Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users.

This license, the Lesser General Public License, applies to some specially designated software packages--typically libraries--of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish); that you receive source code or can get it if you want it; that you can change the software and use pieces of it in new free programs; and that you are informed that you can do these things.

To protect your rights, we need to make restrictions that forbid distributors to deny you these rights or to ask you to surrender these rights. These restrictions translate to certain responsibilities for you if you distribute copies of the library or if you modify it.

For example, if you distribute copies of the library, whether gratis or for a fee, you must give the recipients all the rights that we gave you. By contrast, the GNU General Public License is intended to guarantee your freedom to share and change all versions of a program--to make sure it remains free software for all its users. We, the Free Software Foundation, use the GNU General Public License for most of our software; it applies also to any other work released this way by its authors. You can apply it to your programs, too.

When we speak of free software, we are referring to freedom, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for them if you wish), that you receive source code or can get it if you want it, that you can change the software or use pieces of it in new free programs, and that you know you can do these things.

To protect your rights, we need to prevent others from denying you these rights or asking you to surrender the rights. Therefore, you have certain responsibilities if you distribute copies of the software, or if you modify it: responsibilities to respect the freedom of others.

0. Definitions.
